However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and funeral services you selected.

**Professional Services of Funeral Director & Staff: ----- \$2,950.00**

Our fee for the services of funeral director and staff includes but is not limited to staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; Coordination with those providing final disposition of the deceased. Also included in this charge are overhead expenses relative to our facilities, such as insurance, taxes, maintenance and utility expenses, secretarial and administrative costs, equipment, and inventory expenses.

**Embalming: ----- \$775.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial, or when refrigeration or use of dry ice is available.

**Forwarding and Receiving Remains and Immediate Burial**

**Forwarding Remains ----- \$2,000.00**

This charge includes removal of remains, basic services of staff, and a proportionate share of overhead cost, embalming, air tray and receptacle for body, necessary authorizations, and local transportation to airport or railroad. \* **This charge does not include family viewing, visitation, funeral, or shipping charges.**

**Receiving Remains** ----- \$2,000.00  
 This charge includes pick-up of remains, transportation of remains to cemetery and basic services of the staff. \* **This charge does not include professional services, visitation, or funeral.**

**Immediate Burial** -----\$2,565.00 - \$10,310.00  
 This charge includes removal of remains, local transportation to cemetery, necessary authorization, and basic services of staff. \***This charge does not include casket, the use of facilities and staff for any visitation or ceremony, public or private, prior to burial.**

Immediate burial with casket or alternative container provided by consumer ----- \$2,565.00  
 Immediate burial with minimum cloth-covered, wood casket purchased from funeral chapel ----- \$4,430.00  
 Immediate burial with casket purchased from the funeral chapel (in addition to cost of casket selected) ----- \$2,565.00

**Cremation Services:**

**Direct Cremation** ----- \$2,800.00 to \$7,900.00  
 This charge includes basic services of funeral provider and staff, overhead cost, transfer of remains, transportation to funeral home within 30-mile radius, care of remains, local transportation to the crematory, crematory fee.  
 \* **This fee does not include visitation, funeral service, or urn.**

Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard or wood.

Direct cremation with combustible casket or alternative container provided by consumer ----- \$2,725.00  
 Direct cremation with alternative container purchased from funeral chapel ----- \$2,800.00

**Funeral Service with cremation:** ----- \$7,900.00 and up  
 This charge includes basic services of funeral director and staff, overhead cost, transfer of your loved one to the funeral home within a 30-mile radius, 1-hour visitation and funeral service at Estes Chapel, local transportation to the crematory, crematory charges, embalming, dressing, and casketing, medical examiner's approval fee, temporary urn from the crematory. \***This fee does not include an urn.**

**Crematory Fee** ----- \$600.00  
 For remains over 300 pounds an additional per 100 lbs. ----- \$150.00

If you choose a funeral service where a rental casket is provided, the casket used for the funeral service may have been used in a previous funeral service. If the casket has been used in a previous funeral service, the interior lining has been either replaced or thoroughly cleaned.

## Estes Funeral Chapel Policies

### Payments:

- We accept cash, credit cards, cashier's checks, CASHAPP \$EstesFC, Zelle, ApplePay and money orders. No personal checks accepted and Go Fund Me Accounts are the sole responsibility of the family. \*\*\*3.5% convenience fee will be added to all credit and debit card transactions\*\*\*
- It takes 2 business days for credit card payments and cashier's checks to clear and be verified.
- Once required paperwork has been **verified** and **payment** has been **received**, the funeral service date can be set.

### Insurance:

- We use Heritage Memorial Funding Company to process insurance claims. We do not do assignments.
- The insurance claims take at least **4 business days** to process.
- There is a non-refundable fee of **7%** added to the total sales contract to expedite the insurance claim without a death certificate.
- Once required paperwork for insurance has been **verified** and **payment** has been **received**, the funeral service date can be set.

### County Burial Assistance:

- **NO** Funerals will be scheduled until the county has approved assistance.
- County takes **2 to 4 business days** to process assistance applications.
- If you are denied County Burial Assistance, then our general price list charges will be applied.
- County funerals will only be held Monday through Friday between 10:00–3:30.
- County funerals will only be held at Estes Funeral Chapel.
- County services will only be scheduled for **1 hour visitation and 1 hour service**.
- Families are responsible for picking up death certificates from county service centers.
- Once the required paperwork for county has been **verified** and **payment** has been **received**, the funeral service date can be set.

### Cremains:

- Under Minnesota law, if 30 days have passed and the cremains have not been claimed or disposed of, Estes is required to give written notice that the remains are unclaimed and request further release directions.
- Under Minnesota law, funeral establishments may dispose of unclaimed remains after 120-days.

### Cemetery Requirements:

- Estes Funeral Chapel is **NOT** responsible for **scheduling** or **payment** of cemetery fees. Please visit the cemetery and make the necessary arrangements.

### Death Certificates:

- Death certificates are issued from the Minnesota Department of Health Vital Records Department.
- Estes Funeral Chapel will submit information to the MN Dept. of Health once the MN Dept. of Health has completed them, we will notify you that the death certificates that were ordered may be picked up from Estes Funeral Chapel.

### Disclaimer from Estes Funeral Chapel:

The completion of some certifications is beyond our control and may delay your desired date of funeral services or picking up necessary items, Hennepin County Burial Assistance Program, Insurance companies, cremation authorizations and death certificates.
